

# Regulation – Cinema – English

## I – Date and venue

Article 1 - The Entre Santos Festival - International Festival of Trancoso, is held annually from 2007 in the village of Trancoso, south of Bahia, Brazil, from January 21st to February 02nd.

## II – Purpose

Article 2 - The Entre Santos Festival aims to disseminate and exhibit works in short, medium and long formats, in the categories of fiction, animation, documentary, experimental, video art, musical and environmental, with different themes, suitable for minors and produced anywhere in the world. As well as promoting formation and training in the audiovisual sector.

## III – Registration and material sending

Article 3 – all films and videos suitable for minors are eligible to participate in the selection.  
The Festival only shows films in digital format (DVD).

Article 4 - Registration is open for the period of March 01 to September 30 of each year by submitting the form, which is available on the Web: [www.entresantos.com](http://www.entresantos.com)

Paragraph 1 - The producer / director must submit the form duly completed and signed to the organization of the Festival with the following information:

I – Registration form completed;

II – Free Zone DVD of the film / video for the selection and screening;

III – Posters and photos of the film and the filmmakers, for dissemination;

IV – The foreign films must have subtitles in Portuguese (we request also English and Spanish subtitles).

Paragraph 2 - This material should be sent by mail with the following information written on the outside of the package:

-*Conteúdo artístico para Festival Entre Santos (Shipping for Brazil)*

-*Contenido artístico para Festival Entre Santos (Shipping for Spain)*

Paragraph 3 - The Festival is not responsible for the costs of customs and / or transport of the films.

Article 5 - The material sent for selection (DVD) will not be returned, staying for the collection of Casa Noar - Cultural Association of New Art ([www.casanoar.com](http://www.casanoar.com)).

Single Paragraph - The DVD's of Casa Noar's collection may, at the discretion of the organizers, be used for cultural events executed by Casa Noar, with the proper authorizations from the producers and directors, if they are non-profit.

Article 6 - The producers / directors of the selected works will be informed of the selection two months before the start of the show, this period can be extended at the discretion of the organization of the Festival.

## IV – Selection

Article 7 - A selected jury indicated by the organizers will select among the works registered, having total autonomy to declassify works that are outside the selection of criteria of the Festival or that doesn't deal with the requirements of this regulation.

## V – General and final provisions

Article 8 - The organizers of the Festival reserves the right to show, without charge, in any medium (Internet, mobile phones, television or cinema, etc.) an extract, partial or total, of the work selected for the purpose of disclosure of the Entre Santos Festival.

Article 9 - The selected works will be exhibited within a period not exceeding 90 (ninety) days, in cinemas and / or television networks (open or closed), non-commercial sections, unless expressly restricted by the producer / director.

Article 10 - Signature of the producer / director in this entry form implies acceptance of these rules.

Single Paragraph - This regulation is presented in Portuguese, Spanish and English, but in case of doubt, the prevailing interpretation is in Portuguese.

Article 11 - The omitted cases of these rules will be removed by the organization of the Entre Santos Festival being the decision irrevocable.
